CDTA is proud of our high FYLSX pass rate. 65% passage rate is one of the highest pass rates in the State of California.

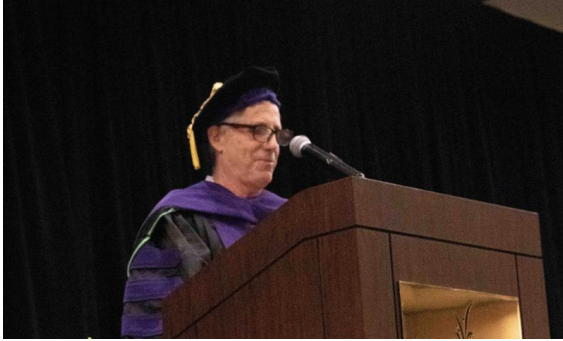
We believe passing the Baby Bar Exam puts students on a firm pathway for CDTA graduation and the successful completion of the California General Bar Exam.
